i. **IMPORTANT INSTRUCTIONS – PLEASE READ CAREFULLY**

1. **Tuition Payment Requirements**

- Tuition fees must be **paid in full** or installments within the **first three months**.
- The **first installment** must be paid immediately after the **registration** is approved.
- The **second installment** is due **within one month after the semester begins**.
- The **final installment** must be completed **at least three (3) months before the end of the semester**.

2. **Mid-Semester Examination Policy**

- Students who **fail to sit for the mid-semester exams on the scheduled dates** will be allowed to sit for **Mid-Deferral Examinations**.
- A **non-refundable fee of MWK 15,000** must be paid before writing the Mid-Deferred Examination.
- Valid reasons and **official approval** are required to access the Mid-Deferred option.

3. **Examination Eligibility**

- Students must have paid **100% of their tuition fees** to be allowed to sit for **mid-semester and final exams**.

4. **Payment Verification**

- Students must attach **proof of payment** (receipt or bank slip) to their registration form.
- Keep a copy of all payment receipts for your own records.

5. **Late Payments and Penalties**

- Any **late tuition payments** may attract a **restriction from academic services**.
- Students are advised to follow the payment schedule strictly.

6. **Registration Deadline**

- Late registration is subject to **penalty fees** and may not be accepted.
